

# 2023 CJA BLACK BELT SUMMER CAMP

- What:** Mini-Camp (4 days) with about 40 classes, campfires, fireworks, Black Belt Exams, sparring, movies, & special events.
- For Whom:** All CJA Black Belts (some classes for Kyus). Must complete a CJA application!
- Where:** Shin Mei Kan, 835 Kienas Road, Kalispell, Montana 59901.
- Cost:** \$140 which includes all meals and classes. **For SMK members /guests who do NOT help with setup/takedown \$2000.**
- Lodging:** Bring your own tent, air mattress, and sleeping bag! It's a CAMP, and you can sleep under the stars!! Profs in Dojo.
- Travel:** Car pool or bus to Kalispell, fly to Glacier International Airport, or train to Whitefish.
- Classes:** Extensive curriculum, all classes taught by our own talented CJA Black Belts.
- To Register:** Complete both sides of this form, including signatures, and mail to Prof. Gene Edwards, **P.O. Box 7174, Kalispell, MT 59904** with a check or money order for \$140 (Do NOT send cash!). Make checks out to CJA. **Postmark deadline is June 10th!**  
**Late registrations must include an additional \$25.00.**
- CJA:** The Christian Jujitsu Association is a 501.C.3 Non Profit Montana Corporation under the IRS. All instruction is freely given without pay. Be sure to thank all your teachers for their generosity, instruction, and service!

**Clothing:** In Montana the weather can change rapidly. Bring summer clothes But also bring a coat, long pants, and a hat (like a baseball cap). Also bring your Gi and several pairs of clean white socks. A **mouthpiece** is required for sparring. Also you may be required to **have your own cup, gloves, foot pads, head gear, etc. for some classes.** The mornings and evenings are cool (sometimes below 32 degrees) so consider PJ's.

**Personal:** Tent, sleeping bag, toothbrush and paste, comb, soap, towel, washcloth, sunscreen, flashlight, sun glasses, slip-on sandals, mosquito repellent, aspirin, Band-Aids, personal medication, notebook, pen/cil, other???

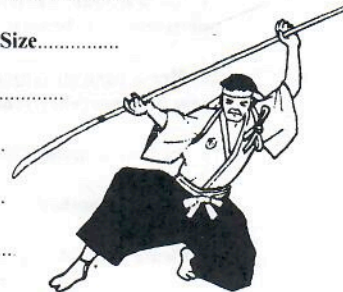

## CJA 2023 Summer Black Belt Camp Info.

1. The Camp Fee is \$140 for 4 days: July 12 to July 15, 2023. On a daily basis it is \$50 per day. Law enforcement and other designated personnel may participate at \$10 per class! Yet they must complete the CJA application for insurance coverage! Shin Mei Kan members/guests who do NOT participate in designated work days must pay retail rate of \$2000 for camp. Meals for part-time participants and visitors are available at the following rates: Breakfast \$10; Lunch \$15; Supper \$20. Black Belt exams will be on Sat. July 9. BOD/BOP meeting will likely be July 5th.
  2. All participants must complete the CJA application. Apps will be available at camp but folks are encouraged to take care of this in advance. Scholarship winners will have their CJA membership covered FREE for camp!
  3. Please use caution as there are many hazards on the property: barbed wire, pot holes, logs, fallen limbs, construction supplies, nails, etc.
  4. Do NOT store food in your sleeping bag or tent: we have had bears and least one mountain lion in the immediate area. The bears have been in our yard! So have fox, coyotes, skunks, and deer. Do not approach any wildlife! Leave it alone, and we will hope it's not hungry!
  5. NO SMOKING! Do NOT use any stoves or open flames in your tents or elsewhere. This is a potential fire hazard area! We will be taking EXTREME PRECAUTIONS during the fireworks and campfire! Only Prof. is to determine when to light and extinguish our campfire. Campfire will be from about 10 to 11 PM. The campfire is NOT to be used at any other time. In the event of wind or other fire danger, we will not have a campfire. We will meet at Mat #1 or other announced location instead. RED FIRE BUCKETS, shovels, and rakes are located on stands around the property. They are for FIRE USE ONLY! They are NOT toys for water games, or trash containers.
  6. Please do NOT sit or lean on any rails! Deck and fence rails are weak, and could give way resulting in injury.
  7. We will NOT have a paid cook, you will be expected to help with food service and clean up. Paper goes in the trash. You can help by wiping down the tables after a meal. If you see a piece of trash on the ground, PLEASE pick it up and put it in the trash barrel. Remember, we don't have a paid staff! This keeps your camp fee down! Wash your hands & use alcohol hand sanitizer regularly.
  8. The house is off limits. Dojo bathrooms and outdoor toilet are both available! Keep dojo doors closed. Weight room is off limits!!!
  9. Please do NOT aggravate the domestic animals or the wildlife (deer, turkeys, etc.).
  10. PARENTS ARE RESPONSIBLE FOR THE CONDUCT OF THEIR CHILDREN! All children MUST be under the direct and immediate supervision of an adult AT ALL TIMES! Horseplay is neither accepted or respected. Be respectful and courteous at all times!
  11. No functional weapons (knives, firearms, etc.) of any kind are allowed without the permission of Prof. E. If allowed, they must never be left unattended, but be secured or supervised at all times. For mat practice, all weapons must be approved by the sensei/instructor!
  12. Please park all vehicles at the lower parking area! The only vehicles allowed up at the house or garage must be approved by Prof. We must leave room for emergency vehicle access (fire engines, etc.).
  13. We have a business phone! NO PERSONAL PHONE CALLS! Call "mom" from your cell phone.
  14. The dojo washer and dryer are available! If you have a problem, ask Prof.
  15. Please help fold/roll up the mats, and move them to different spots at lunch and at supper. If left in place all day, they will kill the grass!
  16. Students who want to attend range classes MUST complete the Range Safety Course first!
  17. Concussion (and related injuries) and illness are NOT covered by our insurance. No hard or focused punches to the head in sparring.
  18. Have fun and enjoy your camp experience! But remember the number one rule in Judo: "Safety First! Horseplay is neither accepted nor respected!"
